

Meeting Minutes: DS General Assembly, 2024-05-20

Time: May 20th 2024, 11:45 – 13:15

Place: HA1, Entrance from Hörsalsvägen 4, Johanneberg

§1. Opening of the meeting

The chair of the Chalmers doctoral student guild, Paul Imgart, opened the meeting at 11:50.

§2. Election of meeting officials

Paul Imgart nominated Lisa Bastås as chair.

Decision: Lisa Bastås was elected as chair

Lisa Bastås nominated Leon Müller as secretary.

Decision: Leon Müller was elected as secretary for the meeting.

Christina Lee and Ioanna Motschan-Armen nominated themselves as reviewers and vote counters.

Decision: Christina Lee and Ioanna Motschan-Armen were elected as reviewers and vote counters.

§3. Approval of electoral register

42 attendees with the right to vote were present. The participant list is attached to this document.

Decision: The electoral register was approved.

§4. Approval of the agenda

Paul Imgart proposes to add the point "other matters" as point §13 to the agenda

§5. Meeting notice in due order

§6. Minutes from previous meeting

The minutes from the previous General Assembly (2024-03-22) were confirmed and made available on DS webpage two weeks after the last General Assembly, in accordance with the statutes.

§7. Election of an auditor for 2024/2025

The nomination committee nominates Rana Saha (Mechanics and Maritime Sciences). There were no self-nominations. Rana introduces himself and answers questions.

Decision: Rana Saha was elected as auditor for 24/25.

§8. Report on current activities

The current DS chair, Paul Imgart, gave a short report on ongoing activities and work performed during the year including:

- Supervisor of the year: Ida-Maja Hassellöv (M2)
- Introduction day
- CHARM
- Representation (Chalmers committees, labor union)
- PhD survey
- Proposals to prevent and handle sexual harassment
- Address problems with departmental duties

Paul answered questions regarding ongoing activities, including internal processes such as the structure of the board and handover procedures. Paul summarized the WESEE group's proposals to prevent and handle sexual harassment cases, highlighting the importance of victims having a person to report to that is not their manager as well as the need for a proper support system for those who experience harassment.

§9. Election of Chalmers doctoral student guild's Chair for 2024/2025

The nomination committee nominated Fredrik Börjesson Sandén (Chemistry and Chemical Engineering) as chair. Fredrik himself was not present in the meeting, but he has accepted the nomination. Gabriel A. Waltersson from the nomination committee introduced Fredrik and answered questions about him. There were no self-nominations. The general assembly discussed Fredrik as a candidate for the DS chair.

Decision: Fredrik Börjesson Sandén was elected as the Chalmers doctoral student guild's Chair for 2024/2025.



§10. Election of Chalmers doctoral student guild's Vice Chair and treasurer for 2024/2025

The nomination committee nominated Yingxiao Yan (Biology and Biological Engineering) as vice chair and treasurer. Yan accepted the nomination, presented himself and answered questions. There were no self-nominations. Yan left the room and the general assembly discussed him as a candidate for vice chair and treasurer role.

Decision: Yingxiao Yan was elected as the Chalmers doctoral student guild's Vice Chair and treasurer for 2024/2025.

§11. Election of Chalmers doctoral student guild's Co-Chair for 2024/2025

The nomination committee proposed Christina Lee (Industrial and Materials Science) as cochair. Christina accepted the nomination, presented herself and answered questions. There were no self-nominations. Christina left the room and the general assembly discussed her as a candidate for the co-chair role.

Decision: Christina Lee was elected as the Chalmers doctoral student guild's Co-Chair for 2024/2025.

§12. Election of Chalmers doctoral student guild's board members for 2024/2025

The nomination committee nominated the following 18 candidates as members of the board 24/25. Gabriel presented those candidates that have not been part of the board before. There were no self-nominations. All proposed candidates accepted the nomination and quickly presented themselves and their motivation to join the board.
